## **Changes to Marine Fisheries Citation Program criteria effective May 1**

The N.C. Division of Marine Fisheries will make several changes to its Saltwater Fishing Tournament criteria, effective May 1. The tournament, popularly known as the Citation Program, is not a competition but a longstanding certification program that recognizes outstanding saltwater catches. Catches that meet minimum weight or release length requirements, along with other qualifications, are eligible for an 8½-by-11-inch citation (certificate) that is suitable for framing.

### **Changes to the requirements:**

- Atlantic bonito and striped bass will no longer be eligible for citations.
- Atlantic croaker will be eligible for a citation at 1 pound, 8 ounces.
- Black drum will only be eligible for a release citation. The minimum release length will remain 40 inches.
- Gag grouper will be the only species eligible for a grouper citation. The minimum weight will remain 20 pounds.
- Sea mullet will be eligible for a citation at the minimum weight of 2 pounds.
- Sharks will only be eligible for a release citation. The minimum release length will remain 80 inches.
- Gray tilefish will be eligible for a citation at the minimum weight of 12 pounds.
- Blackfin tuna will be eligible for a citation at the minimum weight of 25 pounds.
- In addition to the criteria changes, there is now a new online application for anglers who have released qualifying species. Anglers are encouraged to use the online application for released fish but must visit a weigh station for fish that require a minimum weight.

The Division of Marine Fisheries periodically reviews and changes the Saltwater Fishing Tournament criteria to reflect requests from anglers and input from division biologists and to better the program and benefit its participants.

The tournament year runs from Jan 1 to Dec. 31 each year. Any citation-size fish caught in 2021 prior to May 1 will be eligible under the previous citation guidelines. ## **CLEAN YOUR BOAT IN UNDER AN HOUR**

After a day of fishing, successful or not, you have to clean your boat. We have provided some quick boat cleaning tips to make the cleaning process fast and painless so that you can be home for dinner.

If you do it right, a quick boat clean doesn't have to be a bad job. You can still do a 1-hour boat cleaning that leaves her shiny and ready for your next trip.

**PREPPING YOUR BOAT** — The best way to clean your boat quickly is to act preemptively. If you take the extra time in advance and follow proper boat maintenance, you will find that you will have to spend less time cleaning later.

You need to find the right cleaning products for your boat. Pay attention to labels, as not every cleaner or brush is good for every surface. Read reviews to see what products work best on boats similar to yours. Having good quality products will cut down on cleaning time.

Apply a high-quality wax to your boat. How frequently you need to do this will depend on how often you take your boat out. Applying the wax as necessary will make the routine cleanings easier and faster.

Clean as you go. Fishing can be a messy business! Something is bound to get on your boat. If you have the time, use the wash-down system or at least wipe down these messes as you go to save you time later.

### **1-HOUR BOAT CLEANING**

The first thing you should do is rinse off the saltwater using fresh water. Rather than using a hose, a pressure washer may make this process faster. Wipe and scrub your boat down in sections. It will be a lot faster that wasting time moving from one side to the other.

Four hands are better than two. That being said, make sure whoever is helping you knows what they are doing. You do not want any unnecessary damaged to your boat because that person used the wrong brush or cleaner. ###

### *Topic:*

**Mahi-Mahi Fishing**

Fathom Offshore is local company making products on location at company headquarters in Wilmington, NC. Brandon centered talk around Mahi fishing and how to lure and catch this species for his fish tocos. Mahi-Mahi follow a migration path following the bait up the east coast as these fast-growing, aggressive eating fish begin devouring glass minnows in the tropics. They begin their travels off the Florida Keys, move up the coastline off the shores of New England, on an 8000-mile journey they circle back to the tropics. According to tagging studies a 40-pound Mahi is about two years old and will have traveled up the coastline twice swimming 25-50 miles per day eating ferociously along the way.

Brandon looks for water temperature breaks as he trolls 7-10 knots throwing chum chunk bait. He trolls a cut face or flat face plug or Fathom trolling rig in and near a weed line. Once he gets hit or finds fish, he adds a Ballyhoo to the spread. Chuggers will pop over the surface, some riggs allow for a ballyhoo to be pulled behind the lure. Pulling Chuggers is simple, and easy to keep swimming properly.

As the bite begins in Florida Mahi feeding on small glass minnows and catabolizing their own species. By the time they begin to arrive off North Carolina they will have grown larger and be looking for larger baits. Small mahi do not hook-up as easy on the bigger baits, therefore, start the season out using a smaller bait presentation then move to a mix of naked ballyhoo and trolling lures.

Brandon uses a 7-fishing rod spread, a center rod “shotgun” with a bullethead lure 150 feet behind the boat. Two long line outriggers, two flat lines near the side of the boat close to the whitewash, and two rigs on a planner. Rigs that are close to the boat he suggests using rigs that create more splash. A 5-rod spread may be easier to handle and can be done without outriggers, and use a teaser such as Fathom’s “bubble trouble squid chain”. A heaver 6-inch “shotgun” bait should be the farthest bait behind the boat.

Colors: Blue/White is the everyday pull. Fathom manufactures many dark and light contrasting colors and Brandon recommends changing baits out often until one finds what color is attracting Mahi and providing the most action. On overcast days, Brandon prefers more color contrast. If there are a lot of Flying Fish in the area use more skipping baits on the surface and fewer heavier baits. Fathom Offshore lures are manufactured with 150lb Mono; however, some fishermen prefer re-rigging with 50-60lb Fluorocarbon, and no “meat” is necessary to fish Fathom’s lures.

Using teasers and dredges during the summer with 6- to 9-inch-long squids are a must they are package with multiple squids as teasers that can be pulled on a hand line or on a boom. Brandon recommends pulling dredges close or within 20 feet or less in clear bluewater away from the “whitewash”. If using a downrigger for pulling a dredge, keep it so you can see curious fish that come up to check it out. By running a flat line just past the dredge offers an easy prey bait fish that appears to be chasing to catch up with the school. Brandon recommended watching the dredge videos on Fathom Offshore’s website. Attached are several YouTube videos that can be viewed from the website. These videos provide great information to learn more about how to fish Fathom Offshore lures.

**Newly amended rules pertaining to special secondary nursery areas will go into effect Saturday, May 1.**

The rule changes, readopted by the Marine Fisheries Commission in February 2021 under a state-mandated periodic review schedule, reclassify nine Special Secondary Nursery Areas to Secondary Nursery Areas, as recommended by the Shrimp Fishery Management Plan Amendment 1. The nine areas have not been opened to trawling since at least 2004, so there is no change to the shrimp trawl fishery. The reclassification results in additional small mesh gill net attendance requirements in most of the areas:

Newport River, Cape Fear River, Lockwood Folly River, and Saucepan Creek, where attendance in all waters from May 1 - Nov. 30 is now required.

Pungo Creek, Slade Creek, South Creek, and Bond/Muddy creeks, where year-round attendance within 200 yards of shore is maintained with an additional requirement of attendance in all waters from May 1- Nov. 30.

Scranton Creek, which has no change in its small mesh gill net attendance requirements from the reclassification.

Additional rules pertaining to shellfish growing waters, processing of crustacea meat, and oyster sanctuaries were also readopted and will go into effect May 1. Rules in 15A NCAC 03R and 18A:

Amend the oyster sanctuaries rule by adding five new sites (Long Shoal, Little Creek, Pea Island, Raccoon Island, and Swan Island), updating boundaries for three existing sites (Neuse River, West Bluff, and Gibbs Shoal), and removing two sites that no longer function as sanctuaries (Ocracoke and Clam Shoal).

Update shellfish sanitation laboratory procedures, sanitary survey reporting requirements, standards for classifying shellfish waters, and definitions to conform with current national standards.

Correct grammar, typographical errors, and update agency names.

Text of the readopted rules will be posted Saturday in the May 1, 2021 Supplement to the North Carolina Marine Fisheries Commission Rules April 1, 2020 on the N.C. Marine Fisheries Commission's Rules and Regulations webpage. Until May 1, the April 1, 2021 Supplement to the North Carolina Marine Fisheries Commission Rules April 1, 2020 remains in effect. ###

President Kevin Clemmer called the virtual BOD meeting to order at 7:00 PM. *Board Members Present:* Chuck Ward VP, Ron Reijerkerk Treasurer, Fred Adams Secretary, Robert Carroll At-Large, Tripp Adams At-Large, Tommy Peace past president, Jason Fant KMT director, and Bo Nowell Newsletter co-editor. *Board Members Absent:* Greg Brissette At-large, Tommy Walls At-large, and Bernie McCants co-editor.

**Treasurer's Report:** Ron [Reijerkerk](#) reported little change in club finances. Ron pointed out the new website was not reaching new members. He suggested a letter be sent to new members by the club president welcoming them to the club and explaining "How to Login to website".

Ron said he had paid Morehead City to reserve Big Rock Otis Landing waterfront & weigh-in for the RSWSFC King Mackerel Tournament scheduled November 5-7, 2021. ## King Tides—Bernie

In the recent blockage of the Suez Canal with the large cargo ship, the ship was finally freed with dredging around the bow, some large tugs and using the benefit of a “king tide.”

These higher (and lower) than normal tides can affect fishing both positive and negative.

King tides occur when the earth, the sun, and the moon are aligned. From my understanding, when the sun and the moon are aligned and closest to the earth, we get “king tides”. The result, extreme high tides, and extreme low tides. This is because the gravitational pull is essentially “stretching” the earth. Seawater is then pulled in an upward manner causing higher tides in some areas and lower tides in others.

A higher than normal tide will cause red drum to moving into flooded marsh making targeting “tailing fish” a possibility. You might be able to explore areas formally too shallow.

Surf anglers can take advantage of the lower tides to scout the shoreline for beach structure.

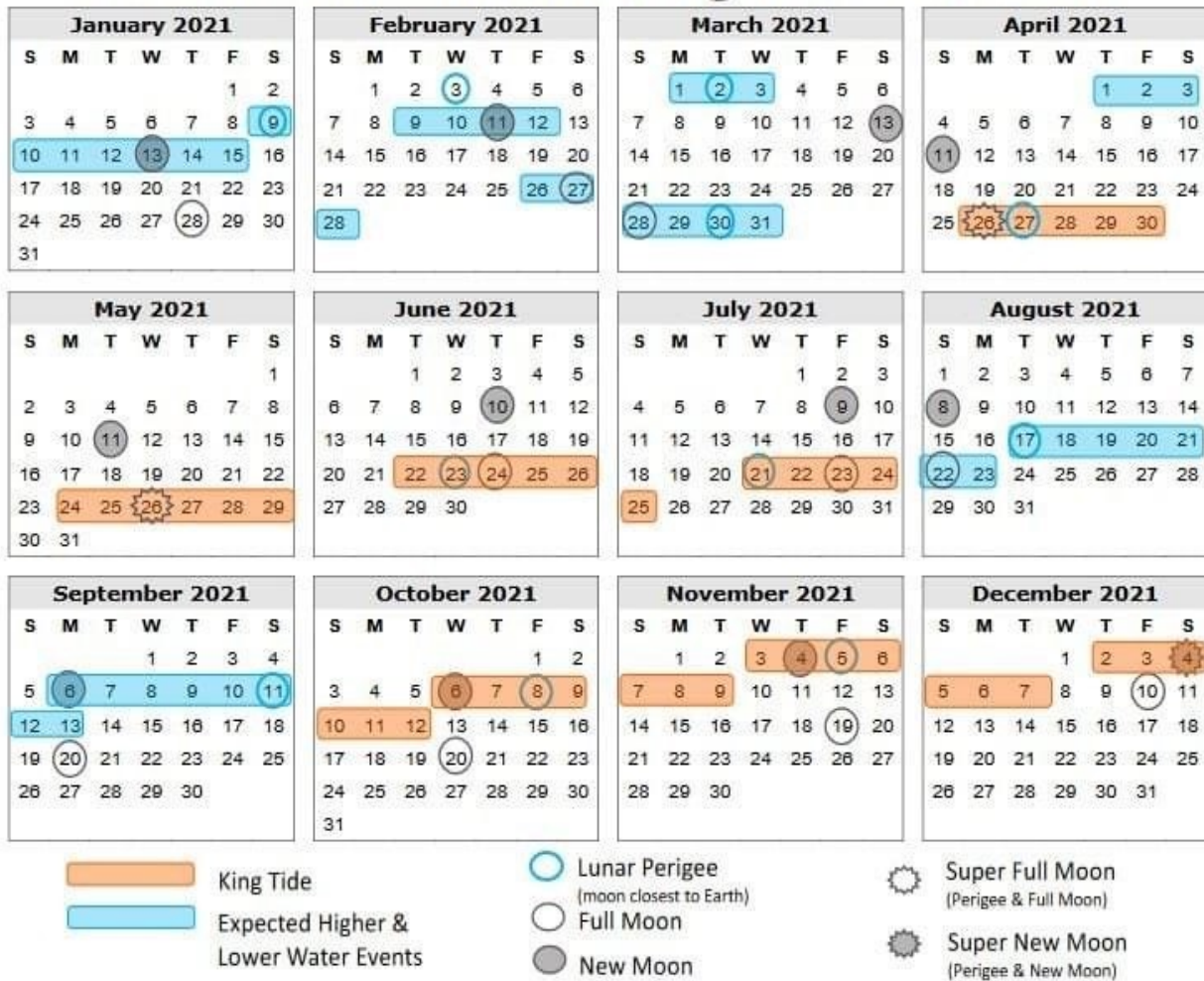
On the negative, the current associated with change of higher highs and lower lows, might make some areas difficult to fish.

Chart below identifies these ‘king tides’ along with lunar tides and full and new moon phases. In the new and full moon phases, expect high tides in early morning and late in the day.

Might be helpful to copy and past the pic to your phone as reference as to what to expect with respect to tides when you go salt water fishing.

A helpful app I have on my phone that I use to monitor tides is *Tides Near Me*.
