Marine Fisheries Division encourages anglers to donate flounder carcasses to science

The N.C. Division of Marine Fisheries will collect flounder carcasses of legal size (15 inches or greater) from recreational fishermen during the upcoming recreational flounder season.

The division has set up eight temporary freezer locations, in addition to the ten carcass collection locations available throughout the year, where recreational fishermen can take their flounder carcasses.

The temporary locations are:

Oden's Dock: 57878 North Carolina Hwy 12, Hatteras;

Bridge Tender Marina: 1418 Airlie Rd, Wilmington;

NC Division of Marine Fisheries: 943 Washington Square Mall Highway 17, Washington;

Sea Gate Marina: 729 Sea Gate Dr, Newport;

Chasin' Tails Outdoors: 709 Atlantic Beach Causeway, Atlantic Beach;

Ocean Isle Marina: 2000 Sommersett Rd SW, Ocean Isle Beach;

Seapath Yacht Club: 330 Causeway Dr, Wrightsville Beach; and

Dudley's Marina: 106 Cedar Point Blvd #8000, Cedar Point.

Anglers that donate legal carcasses and provide a completed carcass collection catch card will be eligible for either an Angler Recognition Certificate (one per season for fish 15 inches to less than 24 inches total length) or a N.C. Saltwater Fishing Tournament Citation (one per fish for fish 24 inches or greater total length). When cleaning the fish, anglers should leave the head and tail intact and, if possible, leave the guts in the fish. Anglers who fished on a charter boat or head boat should let the fish cleaner know the carcass will be donated. ###

Dolphin Biology Exerted from Sportfishing Magazine 2017 https://www.sportfishingmag.com/mahi-secrets-revealed-by-tagging-program/

The Cooperative Science Services' Dolphinfish Research Program released its findings from an extensive study on the species.

Below are some facts previously known about dolphin, along with new information regarding migration patterns, travel speed, and more from the <u>tagging program</u>. In working with anglers through the research program, more than 23,000 dolphin were tagged by nearly 4,600 anglers. A total of 597 tagged dolphin recoveries have been reported. More than two-thirds of the fish marked and released in the 16-year-old study were tagged off the East Coast of Florida.

- They can grow as much as 2.5 inches per week.
- Dolphin can eat up to 20 percent of their body weight in a day.
- They can grow to weights of 40 pounds within the first 12 months of life.
- This species generally reaches sexual maturity at three to five months of age.
- Few dolphin live longer than two years.
- The oldest documented dolphin was 4 years old.
- Lacking an air bladder, they will sink if they stop swimming.
- Spawning likely occurs every month of the year in the western North Atlantic Ocean.
- These fish can travel as far as 152 miles in a straight line during a 24-hour period as shown by a satellite tag track.
- Dolphin were observed to dive to depths greater than 800 feet deep. It is most likely a behavior associated with feeding.
- Dolphin engage in deep diving more at night than during the day.
- Deep diving appears to be associated with feeding on animals that live in the great depths of the ocean during the day that migrate up the water column at night.
- One satellite track showed that a fish released off Charleston, South Carolina, had circumnavigated the Sargasso Sea winding up at the Mona Passage between Puerto Rico and the Dominican Republic six months and around 8,100 miles later, suggesting a migration route that circumnavigates the Sargasso Sea. Dolphin were shown to spend as much as six weeks in large semi-permanent gyres that occur in the North Atlantic.
- Dolphin appear to travel in a clockwise migration in the western central North Atlantic throughout the year.
- The average travel speed of fish tagged off the East Coast of Florida varies annually, ranging from 10.4 miles per day to 44.9 miles per day, with an annual average of 24.8.
- Migration speeds vary by region. Dolphin move slower off the Carolinas than off eastern Florida.
- Dolphin are capable of sustained high-speed travels. An example is a fish that went from the Florida Keys to Oregon Inlet in nine days, covering 893 miles. The longest distance traveled by a tagged fish from its release site belongs to a fish released off Charleston, South Carolina, that traveled 2,500 miles in a straight line into the eastern North Atlantic.
- Small fish tagged off the U.S. East Coast returned the next year as large adult fish, shown by 26 such recoveries. ###

Another Victory for Citizen Coalition in Coastal Fisheries Lawsuit

Unanimous Court of Appeals Rejects State of North Carolina's Arguments

In a unanimous decision today, the North Carolina Court of Appeals rejected the State of North Carolina's request for immunity from a lawsuit brought by 86 citizen plaintiffs and the Coastal Conservation Association of North Carolina to hold the State accountable for mismanaging North Carolina's coastal fisheries. In July 2021, a Wake County trial judge rejected the State's request for immunity from the lawsuit. Today, a three-judge panel of the North Carolina Court of Appeals affirmed that decision, rejecting the State's arguments and ruling in favor of the citizen coalition and CCA NC on every issue.

As the Court of Appeals' opinion explained, the State has "an affirmative duty . . . to preserve the people's right to fish and harvest fish," which includes a "duty to preserve fisheries for the benefit of the public" and a "duty to keep fisheries safe from injury, harm, or destruction for all time." The Court of Appeals' unanimous ruling means that the lawsuit will proceed to a stage where the plaintiffs have an opportunity to establish the merits of their claims-claims that CCA NC and the citizen coalition maintain are supported by overwhelming evidence and the State's own data. "We are gratified by the Court of Appeals' unanimous decision, which reaffirms over a century of precedent and upholds a constitutional amendment ratified by approximately 60% of the voters," said CCA NC's Executive Director, David Sneed. "We look forward to proving our case on the merits and ensuring that a legacy of sustainable coastal fisheries will be there for all our children and grandchildren."

State certifies new state record swordfish

The N.C. Division of Marine Fisheries recently certified a new state record swordfish (Xiphias gladius). Cary Carney of Newport caught the 504-pound, 8-ounce fish about 55 miles off Morehead City on Aug. 21. Carney was fishing aboard the Willow B, captained by his son, Brandon Carney. They were fishing in roughly 1,300-foot-deep water when they encountered the "sword of a lifetime," according to Carney.

Carney's fish measured 104 inches fork length (from the tip of the nose to the fork in the tail) and had a 53-inch girth. It was weighed in at EJW Outdoors of Morehead City.

Carney landed the fish using 65-pound test line, hand cranked on a Diawa MP3000 reel that had a blown fuse. It was paired to a 6-foot Crowder DDS80 rod, and he used albacore belly for bait.

NC DMF Announces Scoping Period for Striped Mullet

At the August meeting of the NC Marine Fisheries Commission, during the discussion and vote to adopt Amendment 2 to the Estuarine Striped Bass Fisheries Management Plan, led by Commercial Member Doug Cross, the Commission came within one vote of putting gill nets back in above the ferry lines on the Neuse and Pamlico Rivers. The final motion failed on a tie vote (4 to 4) due to one new commissioner being unable to attend the meeting. After much debate, the Commission eventually voted to table the final vote until the November meeting where commercial fishing interests will again try to reopen the rivers to gill netting.

A consistent argument from commercial interests on the reopening of gill netting on the Neuse and Pamlico rivers above the restricted areas, currently at the ferry lines, was the need to target striped mullet in the summer months.

The Division of Marine Fisheries has opened the public scoping period for Amendment 2 to the Striped Mullet FMP to solicit public input on potential management strategies. The most recent stock assessment has determined that the stock is both overfished and overfishing occurring and the stock needs a 20 - 33% reduction in total removals.

The scoping document for the Striped Mullet FMP can be found here: open (nc.gov) Please note that one of the management options under consideration is "Area Closures". Commission Chairman Rob Bizzell said it best, "(DMF) staff is telling us striped mullet are over-fished. Opening these waters to additional harvest would be irresponsible."

Why would any commissioner propose new regulations that would encourage the additional harvest on an overfished stock? Why would other commissioners support any motion that would encourage additional harvest on an overfished stock?

Please make your voice heard and support keeping the gill net restrictions in place on the Neuse and Pamlico rivers.

Division of Marine Fisheries announces scoping period for striped mullet

The Division of Marine Fisheries is developing Amendment 2 to the N.C. Striped Mullet Fishery Management Plan (FMP). The division will hold a public scoping period Sept. 26 to Oct. 7 to solicit public input on potential management strategies for the upcoming amendment and discuss stakeholder priorities. Scoping is the best opportunity for the public to inform the plan.

The primary management strategy for Amendment 2 is long-term sustainable harvest in the striped mullet fishery. The benchmark stock assessment indicates the resource is overfished and overfishing is occurring.

Following the public comment period, the public is encouraged to discuss subject matter concerns directly with species leads in small groups.
